### Article 1.

1.1. The subject of these Regulations is to regulate the rights and obligations of the Organizer and Exhibitor in organizing the GR8 Coffee Festival, where Geldbaum d.o.o. is the organizer of the festival, and the Exhibitor d.o.o. is the exhibitor at the festival.

1.2. The GR8 Coffee Festival is a three-day event that will take place in Zagreb, at LAUBA, from 10.04.2025 to 12.04.2025 (hereinafter: the Festival), during which promotions, tastings, practical workshops, presentations, competitions, and similar activities will be held.

#### Article 2.

2.1. The Organizer is a company that, as part of its registered activity, carries out promotional activities, designs, and organizes cultural and entertainment events and promotional events and has the material and human resources necessary to organize and hold the Festival.

2.2. The Organizer will perform all organizational activities necessary for the Festival, including but not limited to activities such as program definition, the organization of promotions, tastings, practical workshops, presentations, and competitions, as well as the financial management of the Festival, i.e., all activities necessary for the successful implementation of the Festival.

### Article 3.

3.1. The Organizer has contracted cooperation with the company Štand expo d.o.o., Gornji Stupnik, Gornjostupnički odvojak 7, OIB: 29980236683 (hereinafter: the Contractor) for the construction of stands at the Festival.

3.2. The contracting parties agree that the Contractor will build the stands and carry out related work in the Exhibitor's area according to the direct instructions of the Exhibitor, and the Organizer will not be held responsible for any damage that may result from the Exhibitor's instructions. The Exhibitor will contact the Contractor through the Contractor's authorized representative with the following contact details:

3.3. The Contractor will issue an invoice for its work. The Contractor will invoice the Organizer for all costs specified in Article 3, paragraph 1, points 1) and 2) of this Agreement, while any other additional costs not covered by these provisions will be directly invoiced to the Exhibitor.

3.4. The Exhibitor is not authorized to make modifications to the contracted space that would significantly change the purpose of use, construction, layout, area, or external appearance, nor may they install equipment on the ceilings (hanging equipment).

3.5. The Exhibitor is not entitled to a refund for any funds invested in the design, installation, or decoration of the contracted space.

# Article 4.

4.1. The contracting parties agree that tickets for the Festival will be sold through the Entrio system, and the Exhibitor is responsible for ensuring a sufficient number of tickets for themselves and their partners.

4.2. The Exhibitor is obliged to provide the Organizer, for the purpose of issuing

accreditations, no later than April 5, 2025, by email to <u>hello@gr8coffeefestival.com</u>, with the following information:

- 1) names and surnames of persons authorized by the Exhibitor to work on the setup before the Festival opening on April 8-9, 2025, and for dismantling after the Festival ends on April 13, 2025.
- 2) names and surnames of persons authorized by the Exhibitor to work at the Exhibitor's booths during the Festival, from April 10-12, 2025.
- 3) license plates of delivery vehicles authorized by the Exhibitor. The contracting parties agree that deliveries may be made on the days specified in the previous two points, from 9:00 AM to 9:30 AM.

4.3. The Exhibitor is obliged to inform their employees or authorized persons, whose data will be provided to the Organizer for accreditation purposes, about the transfer and sharing of personal data for this purpose.

4.4. The Organizer will not use the personal data of the employees/authorized persons of the Exhibitor for purposes other than those required by Croatian law or for fulfilling obligations as a data controller, about which the data subjects will be clearly and unequivocally informed.

4.5. The contracting parties confirm that personal data is collected and processed in accordance with the requirements of Regulation (EU) 2016/679 of the European Parliament and the Council of April 27, 2016, on the protection of individuals regarding the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

4.6. The contracting parties agree that the venue where the Festival takes place is under video surveillance installed by KUĆA LAUBA d.o.o., Prilaz baruna Filipovića 23A, 10000 Zagreb, Croatia, OIB: 15479326659 (hereinafter: KL), who is the independent data controller for the video surveillance system.

# Članak 5.

5.1. When furnishing, equipping, and using the contracted space, the Exhibitor is obliged to apply work safety and fire protection regulations, comply with technical instructions, and take the necessary measures and actions to protect the entire property, in order to prevent events that could cause material damage or injury to visitors, or hinder the quick and unobstructed evacuation from the endangered area.

5.2. In the event of building additional structures in the Festival area by the Exhibitor or its authorized persons, the Exhibitor is obliged to install technically sound equipment and ensure that all work is carried out in accordance with technical regulations and professional rules related to this type of work and contracted activities.

5.3. The contracting parties are obligated to maintain and test their equipment, and each party is responsible for the consequences of neglecting this obligation. The boundary for maintenance responsibilities and the point of handover of electrical energy is located at the low-voltage distribution area, at the ownership boundary between KL's basic assets and the Organizer's. KL, under the contract with the Organizer, will inspect and, if necessary, certify and approve the Execution Project solely related to connecting the Organizer's installations and equipment to KL's infrastructure, while all other aspects (work safety measures, fire protection, necessary static calculations, wiring, telecommunications, etc.) are the sole responsibility of the Exhibitor for their exhibition space. The Organizer bears no responsibility in this regard. In the event of such damage, the Exhibitor agrees to cover all costs of damage repair.

5.4. The Exhibitor is obliged to take care of the space entrusted to them with the care of a prudent businessperson, to adhere to the House Rules of KL, the Fire Protection Regulations, and the Technical Instructions, and to keep the space clean.

5.5. During the working hours of the Festival, the Exhibitor bears sole responsibility in the event of theft or damage to their own equipment and associated installations, as well as for any injuries or damage suffered by persons authorized by the Exhibitor to work at the Festival. The Organizer is responsible for any theft or damage to equipment and installations outside of the Festival's working hours.

5.6. The Exhibitor is materially and criminally responsible for any accidents that occur due to non-compliance with the aforementioned regulations and laws, in relation to their exhibition space, both towards the Organizer, KL, and third parties.

5.7. In the event of any damage caused by the Exhibitor in the use of the contracted space, as well as roads, green areas, installations, equipment, shared areas, and similar, the Exhibitor is obliged to cover the costs of repairing the damage and restoring the previous condition.

5.8. The contracting parties agree that the Organizer is not responsible for the number of visitors to the Exhibitor's stand, nor for the visibility and attendance of the stand.
